

The hearing is scheduled for 10:00 A.M. on Tuesday, May 4, 1993, and will be held in room SD-215 of the Dirksen Senate Office Building. In announcing the hearing, Senator Moynihan said: The President has proposed that we tax Social Security benefits more like we tax private pensions. It is a reasonable proposal. Our purpose will be to give it a full and fair hearing and to hear views from all perspectives. Under current law, up to one-half of an individuals Social Security benefit is subject to income tax if the individual has countable income in excess of \$25,000 per year (\$32,000 for a couple). The President has proposed to tax up to 85 percent of a recipients Social Security benefit, using the same income thresholds.
